

# A LETTER FROM THE GENERAL MANAGER

It's hard to believe we're nearing the end of another fantastic summer in Canyon Lake. As the saying goes, time flies, but memories last forever. I hope everyone made wonderful memories this summer in our beautiful community. Whether it be our epic kick off to summer, Fiesta Hopper or simply relaxing on the sandy beach or enjoying a leisurely boat ride, there have been countless opportunities for good times here at home.

As we look forward to fall, we have a full calendar of events and activities planned for the community. One standout on the horizon is the 17<sup>th</sup> Annual Canyon Lake Car Show on October 7 — it's an event I personally look forward to. I'd definitely suggest marking your calendar to come out to see the incredible lineup of decked-out vintage cars. You can read more about this fun event on page 12.

On the projects side, we continue to make great progress renovating the Lodge. This highly anticipated project came after years of development. The Lodge has a prime location on the lake boasting breathtaking views. The facility is host to many community events and private functions throughout the year. While the Lodge facility dates back to almost the community's inception, the original building was demolished and rebuilt in 2000, 23 years ago. Many of the finishes inside the building are original, making them 23 years old and, at this point, very worn and dated. The bar area was last updated in 2014, over nine years ago. The outdoor space has become an increasingly popular revenue center, with weddings and events on the front lawn. However, the great view of the lake was almost totally obscured by hedges and trees. Further, the facility offers limited outdoor dining/ bar areas. During Covid-19, we converted the existing outdoor sidewalk and patio into a dining area that turned out to be incredibly popular.

After two decades of hard use, we hired an excellent design team to coordinate a large-scale renovation at the Canyon Lake Lodge. A significant outdoor expansion is underway with a new outdoor service bar designed specifically to serve a much larger front patio dining area and event/wedding space. You can read more about this project on page 8.

Another project I am excited about is the additional pickleball courts coming to Eastport Park. The current pickleball courts at this park were built in 2017 and have since become an exceptionally popular amenity. The current four courts are often crowded, and the new courts are being added to help alleviate that problem. In addition to the new courts, the existing four pickleball courts will also be resurfaced. The new pickleball courts are an exciting addition to Eastport Park and will provide more opportunities for Canyon Lake residents to enjoy this popular sport.

Lastly, we have a couple of projects that are wrapping up. I'm pleased to say the Canyon Lake Drive Medians project is now complete, and our community now has a whole new beautiful first impression. These medians, original to the community, were bare, and the large trees were uprooting the curbs and the street.

Another project wrapping up is our solar project. New solar structures have been added at the Equestrian Center, Lodge, and Golf Course. These structures had no upfront costs; instead the Canyon Lake POA will purchase the generated electricity at a much lower cost than current rates. We are expected to save millions over the next 25 years. Additionally, we have started a project at the driving range to improve the original driving range grass area with new surfaces better suited for shade, leisure, and practice.

I hope everyone has a wonderful fall and that you enjoy this issue of Canyon Lake Living!

The Lodge Renovation Project is in full swing, and we anticipate its completion later this year. A remarkable transformation awaits at the Lodge, where an exciting outdoor dining experience is taking shape right in the heart of picturesque Canyon Lake. Our brand-new Sunset Lounge & Terrace is nearing its completion, promising a dining experience by the lake that's truly unparalleled.

### **PICKLEBALL COURTS** ADDING 2 MORE COURTS!

Canyon Lake residents and guests will soon enjoy even more pickleball games in Canyon Lake! Construction is underway on two new pickleball courts at Eastport Park. These courts are being added to the four that were built in 2017 and are expected to be completed in the fall.

Pickleball is a racquet sport that combines elements of tennis, badminton, and table tennis. It is a relatively new sport but has seen rapid growth in popularity in recent years. In Canyon Lake, the sport has become very popular and the current four courts are often crowded. The new courts are being added to help alleviate that problem. In addition to the new courts, the existing four pickleball courts will also be resurfaced. The



new pickleball courts are an exciting addition to Eastport Park and will provide more opportunities for Canyon Lake residents to enjoy this popular sport. The Canyon Lake POA Board approved funding in the amount of \$332,486 plus a 5% contingency from the CIP fund and \$29,800 from the Reserve Fund at their March 7, 2023 Regular Session Board Meeting.



### Canyon Lake has a whole new look and feel when you are entering the community's main entrance! After months of work, new life has been restored into the 55-year-old medians on Canyon Lake Drive South. These medians, original to the community, were bare, and the large trees were uprooting the curbs and the streets. The Canyon Lake POA hired a landscape architect with extensive experience in center median design to create a new look that would improve the visual appeal of the desolate medians. Now complete, there is new landscaping, trees, and uplighting that accentuate the new landscape. Additionally, a new left-turn lane was added onto Bluebird Drive creating safer access and new curbing to eliminate the old mailbox turnout before **Continental Drive.**

Work wrapped up in July 2023. This project was completed for the approved funding amount of \$630,000 (plus 8% contingency) that the Board approved in the December 2022 Regular Session Board Meeting.

# **50 YEARS OF HARD** WORK & DEDICATION

The Tuesday Work Group (TWG) has been a driving force in maintaining and beautifying the Canyon Lake Golf Course for over 50 years. This group of dedicated Golf Course volunteers has significantly impacted the course's upkeep while saving the Canyon Lake POA a substantial amount of money in maintenance expenses.

TWG traces its origins back to 1973 when a group of golfers decided to pick up loose rocks on the Golf Course and fairways after their rounds. This initial effort soon evolved into a broader range of projects, including forming cart paths, trimming trees, and welding handrails. In 2003, TWG's charter was officially approved by the Canyon Lake POA, designating it as a standing committee with the primary responsibility of improving the Golf Course. Today, TWG boasts a membership of over 40 individuals, with some having dedicated over three decades of service. Their collective efforts result in approximately 2,000 to 3,000 service hours each year.

The impact of TWG's dedication and expertise is evident in numerous enhancements made to the Canyon Lake Golf Course. They have taken on major projects such as setting giant boulders at each tee and mounting bronze plaques, installing benches, and assisting with installing a post clock at the putting green. In addition, TWG has tackled crucial maintenance tasks, including repairing golf cart paths and filling divots left by golfers. Through their ongoing efforts, TWG works towards making the Golf Course a visually appealing and well-maintained community asset.

Recently, TWG celebrated a major milestone — their 50<sup>th</sup> anniversary. Past and present members gathered at the 10th tee to unveil a plaque commemorating their dedicated volunteer labor throughout the years. This event highlighted the group's evolution from a small gathering of rock pickers to a thriving organization responsible for substantial improvements on the Golf Course. Recognizing their exceptional contributions, the Canyon Lake POA selected TWG as the grand marshals of the 2023 Fiesta Hopper Parade — an esteemed honor that further emphasizes their integral role in the community. Additionally, the group hosted a banguet in June to commemorate their remarkable 50<sup>th</sup> anniversary. The event was a grand celebration of their half-century commitment to enhancing the Golf Course and their invaluable contributions to the community.

Over the course of 50 years, TWG has not only

# **GOLF COURSE ANNUAL OVERSEEDING**





Each year, the Canyon Lake POA closes the golf course for approximately three weeks to overseed the fairways, roughs, tees, and green surrounds. This year's overseeding will take place starting October 9 through October 29. The golf course will be closed during this time, and the Golf Pro Shop will be closed October 9 through October 22. Additionally, the Country Club Bar & Grill will be closed from October 16 through October 29 for its own scheduled annual maintenance.

### WHAT IS OVERSEEDING?

Simply put, overseeding is the process of applying grass seed over an existing type of grass. In our region, the desert southwest, bermuda grass is a popular choice at golf courses for its heat and drought tolerance, rapid recovery rate, and nominal fertilizer requirements. However, when cooler weather comes around mid-December through February, the grass will go dormant, turn brown, and become difficult to play on. For this reason, we overseed with grass more favorable to colder conditions, such as perennial ryegrass.

Successfully growing an entirely new grass is no small feat. To begin with, we must wait for the existing bermuda grass to have a slower growth, which generally occurs as the weather cools in October. This paves the way for the seed bed preparation, then seed application, followed by seed germination, seed establishment, and finally, the first cut. These steps require a certain amount of time to complete, with a total timetable of approximately 18 days. During this time, all areas overseeded must remain wet for several days to germinate the seed. The irrigation system is programmed to water several times throughout the day, ensuring that the seed stays moist.

When the golf course reopens, the juvenile seedlings are often still weak and must be protected from golf cart traffic. The golf carts are asked to remain on the cart paths during this time, approximately three weeks after reopening. Canyon Lake's rolling hills make for a challenging and varied course for walking, jogging, or cycling!




### NORTH GATE TO CANYON LAKE DRIVE Distance: 1.9 miles This challenging route ebbs and flows through several hills and provides a great whole body workout, no matter

what the exercise.



### MOONSTONE TO HAPPY CAMP Distance: 1.6 Miles This lakeside route offers fitness enthusiasts sweeping views of the lake for a majority of the route.



MAIN GATE TO VACATION DRIVE Distance: 1.2 miles This route features multiple hills, making it a great choice for a brisk walk, jog, or cycle.



### EVANS PARK TRAIL

Distance: 1.8 miles

Evans Park West features a walking and jogging path with exercise stops that winds through 1.8 acres of mature trees and landscape.





### CONTINENTAL DRIVE Distance: 1 mile Take a stroll on Continental Drive, and you will enjoy views of the golf course on your walk.



### EAST GATE TO VACATION DR. Distance: 1.6 miles

Electric Shock Drowning (ESD) severly injures and kills people each year. ESD occures when faulty wiring sends electric current into the water, which passes through the body and causes paralysis, which could result in drowning.



# INSPECT YOUR DOCKS!



Any electrical installations or modifications on private property or within the EVMWD shorezone **must be permitted and inspected by the City of Canyon Lake Building Department.** Homeowners should hire a California Licensed electrical contractor to make any electrical modifications to their dock.

All dock electrical must be installed in accordance with the latest edition of California Electrical Code as adopted by the State of California. All circuits must be GFCI protected (CEC210). Non-metallic sheathed cable (Romex) is not permitted (CEC334.12). All installations, such as receptacle boxes or subpanels, should be listed as approved for wet locations and mounted two feet above dam elevation of 1382 feet.

# **GUEST CALL-IN SERVICES**

Canyon Lake residents have multiple opportunities to invite their visitors into the community with dwellingLIVE, an access control software industry leader that manages our convenient online guest call-in system. Through the online platform or mobile app, residents can add short-term and long-term visitors and service providers, such as contractors, service workers, delivery drivers, etc. Visitors receive a guest pass for the duration of your authorization; at most ten days. While your visitors may enjoy access to our amenities with your companionship, service providers are not

authorized to park or utilize our amenities.

As a reminder, the Canyon Lake POA periodically clears the permanent guest list to ensure the list is up-to-date and reflects desired guests in the community. The list was most recently cleared on August 31. We encourage residents to utilize the new permanent guest list feature in your dwellingLIVE app or website account to manage your permanent guest list conveniently. Alternatively, you can visit the Canyon Lake POA Member Services office for assistance. Permanent guests do not have an expiration. However, guest passes are only issued for up to ten days.

Although this is a thrilling holiday for all, there are some important things to know to ensure the protection of children and grown-ups alike. The Riverside Sheriff's Department offers some of the following tips to help make this a fun and enjoyable holiday for all.

### **PASSING OUT TREATS**

- Welcome "trick-or-treaters" with your porch lights and any exterior lights on.
- Do not give homemade or unwrapped treats to children.
- Keep dogs and other pets away from doors so children will not become frightened or injured.

### TRICK-OR-TREATING

Avoid vision-impairing costumes and costume

that could cause you to trip. Also, be sure to wear comfortable shoes.

- Designate a specific route to take and a time to be back home.
- Never trick-or-treat alone. Go with at least two friends for the entire evening.
- Carry a flashlight and use it so drivers can see you and so you can see hazards on the street as well as other people.
- Look in all directions before crossing the street, and obey all traffic signals. Walk! Never run across the street.
- Do not accept rides from strangers.
- Do not take short cuts through backyards, alleys, or parks.
- Do not go inside anyone's home. Remain on the porch/front door area at all times.

### **TIPS FOR MOTORISTS**

- Exercise extreme caution when driving a vehicle. Be on the alert for excited children, whose vision may be obscured by masks, darting out into traffic.
- Motorists should avoid all unnecessary travel on Halloween evening, and when driving they should drive slowly and be alert.
