# II. Approval of Minutes:

# III. <u>Discussion Item(s)</u>:

- a. Input from board regarding any issues needing to be researched/addressed:
  - Ebikes (speed, seats, unsafe riding) and Crowds on Holidays Both need to be reviewed at some point in the future.
- b. Continue to classify rules (fines) into their respective tiers
- c. Review Garden Club proposed rules for Evans Park build out
  - In the buildout, there will be approx. 20 (4' x 8') plots
  - The Garden club has submitted a proposed set of rules they would like to be adopted
  - Committed reviewed the 2 sets of rules and application process. It was determined that further review will be completed and a set of rules will be proposed in the future
  - Proposed rules to be completed by net meeting on July 18, 2023 so they can be presented to the board by the August 2023 meeting.

# IV. Action Item(s):

#### GR.5.2a Personal Electric Devices

- Reviewed and revised current rule(s) as it relates to safety
- Discussion was completed around options to make the riding of ebikes safer within the community. A few items discussed were: one rider per seat, a safety exam, use of helmets, lights, and age.
- After discussion, the committee drafted a revision to the current rule. A motion was made by Craig and a second was made by Kellie to present the proposed rule change to the board for review/approval. All in favor.

#### **GR.5.2a Personal Electric Devices**

Electric bicycles and other personal electric devices such as electric stand-up scooters, skateboards, and wheeled boards are permitted to be used within the community so long as the following provisions are followed:

*Class 4 electric motorcycles are prohibited in Canyon Lake			

# **GR.5.2b Motorized Bicycle Registration**

Requirements that must be met for motorized bicycles are as follows:

Member must be authorized and in good standing. Completion of the CLPOA E-Bike Safety Exam will be verified at the time of registration. CLPOA issued decals must be displayed on the front, left fork, for all motorized bicycles.

Fine Amount: \$100.00

## **GR.5.2c Light Requirements**

All motorized bicycles ridden on Canyon Lake streets or common areas after sunset and / or before sunrise must be equipped with functioning headlights and taillights.

Fine Amount: \$100.00

# **GR.5.2d Scooters / Motorized Boards**

All scooters and boards must have a floorboard to stand on when riding.

Fine Amount: \$100.00

#### **GR.5.2e Passengers**

Only one rider per seat or floorboard on all personal electric devices.

Fine Amount: \$100.00

## **GR.5.2f Reckless Behavior**

No reckless or unsafe riding (weaving through traffic, running stop signs, double-riding, use of cellular devices, excessive speed, going against traffic, etc.) on any personal electric device.

Fine Amount: \$200.00

#### Garden Club Rules

 Discussion and roundtable was completed regarding the Garden Club and if they should have there own set of rules or follow the rules established for the park(s). After discussion, the following set of rules were created to be presented as G.C.1 – G.C.8 to the board for further review before a motion would be made/approved for official presentation.

# Garden Club (GC)

## **G.C.1 Members in Good Standing**

Members must be in good standing to utilize an assigned plot.

#### **G.C.2 No Loitering**

Loitering is not permitted in the gardening area. Only Members with assigned plots are allowed.

## **G.C.3 No Smoking**

No Smoking anywhere within the boundaries of the Gardens

## **G.C.4 No Profanity**

No Foul language allowed.

#### G.C.5 No Pets

No Pets are allowed in the Gardens

## **G.C.6 Hours**

Gardening hours are from 6 a.m. to 10 p.m.

#### **G.C.7 Alcoholic Beverages**

Alcoholic Beverages are not permitted in the gardens.

#### **G.C.8 Prohibited Plants**

No poisonous, toxic, or illegal plant growth (i.e. poison ivy, cannabis, etc.).

## **G.C.9 No Unkept Plot / Pests**

No plot may become overrun, neglected, or unkept as to attract unwanted pests or rodents.
